



MEMBERSHIP TYPES

Membership in NRRDA is open to anyone engaged in the defense of the retail and restaurant industries, employed by a restaurant or retail establishment, insurance company, third party administrator, claims adjusting company, structure settlement company or anyone else with an interest in the retail and restaurant industries.

Industry Members are employed by a retail or restaurant establishment, insurance company, or are in-house counsel. **Membership is free.** Sample industry member companies include:

Vendor Members are those involved in the investigation and defense of claims filed against retail or restaurant businesses, such as field adjusters, expert claim adjusters or employees of settlement companies. Membership is \$425 annually.

Attorney Members regularly defend retail or restaurant companies or those affiliated with the industries and whose law firm does not represent personal injury plaintiffs against the industries. Criteria for Attorney Members are selective and subject to an application process. Membership is \$525 annually.
